- To ensure continual improvement and rel evance, it is essential that this process re mains adaptable and responsive to the evolving educational landscape. Regular review and re nement of the assessments,
- along with feedback from educators, candi dates, and other stakeholders, will be crucial in maintaining the rigor and effectiveness of the teacher-candidate readiness process. Additionally, providing ongoing profession
- al learning opportunities for teacher candi dates and educators will help reinforce this
- foundational knowledge, ensuring that they are well-prepared to meet the diverse needs
- of students and uphold the high standards of teaching excellence in New York State.

## Supplementary Certi cate and Supplemen tary Bilingual Education Extension

The Board of Regents adopted a regulatory amendment to Sections 80-2.9, 80-4.3, and 80-5.18 to allow exibili ties for the Supplementary Certi cate and Supplemen tary Bilingual Education Extension requirements. Candi dates may demonstrate that they have the knowledge and skills to provide the necessary supports to recently arrived and asylum-seeking students by completing ei ther the examination requirement or the enrollment and education requirements. This amendment will be valid through August 31, 2025.
